Date: January 8, 2020

PERSONNEL -

Patrick Beckley of the Fire Prevention Bureau, has accepted the recently vacated field inspector position that is headquartered out of Tuscarawas County. Patrick's first day with BUSTR commenced on November 10, 2019.

Environmental Specialist Richard "Rick" Krueger retired on December 27, 2019. Tanya Nell was hired and commenced work on January 6, 2020 to backfill the vacant Environmental Specialist position.

ADMINISTRATION -

The responsible party search program for FY20 is waiting on finalization of vendor contracts. There is currently \$68,000 in LUST grant dollars dedicated for this program that will be used to perform 68 responsible party searches.

The ODSA's Abandoned Gas Station Cleanup Fund Program is ongoing with <u>96</u> BUSTR facility releases involved, 106 grant applications received, 91 awards approved with 6 applications currently under review. <u>20</u> property cleanups have been completed with \$18,769,174 million of the allocated \$32 million having been awarded.

TRAINING AND STAFF DEVELOPMENT -

Commerce Human Resources and the Department of Administrative Services continue to provide various training and informational sessions for Commerce employees. All staff have completed "Ethics" and "Securing Commerce" training through the ELM portal.

TRAINING TO STAKEHOLDERS –

On November 7, 2019 Steven Krichbaum gave a presentation to Building Environmental Council of Ohio. An overview of the latest UST operational compliance requirements was provided along with an overview of UST compliance program in Ohio. 51 individuals were in attendance for the training.

ACTIVITY -

OTTER Database

IT Commerce worked with BUSTR to develop the new UST operational compliance statistics report that was used for the end of year U.S. EPA LUST-4 reporting on October 1, 2019. BUSTR is the first program in U.S. EPA Region 5 to report the new statistics.

Click Scheduling

No issues to report. BUSTR is in the first year of a new 3-year operational compliance inspection cycle. Approximately 7,100 facilities will be inspected over the next 3 years.
