ADMINISTRATION –

Responsible Party Search Project

The contracts relating to the FY22 responsible party search have been awarded. Over \$74,000 in LUST grant dollars is dedicated for this program. 44 searches have been completed thus far.

Customer Centric Activities/Service

BUSTR personnel are working adjusted schedules that include three days a week at the central office. BUSTR is undergoing its five-year rule review with an anticipated effective date of July 31, 2022 for any amended rules. All customer inquiries/questions are being timely responded to by field and in-house staff. The corrective action staff are successfully reviewing electronically submitted and hard copy submitted reports in a timely manner while the field

inspection staff are performing operational compliance inspections of underground storage tank facilities at a pre COVID rate. All public information requests are being timely provided to BUSTR's customers.

FY21 & FY22 LUST Grant Application

The FY22 portion of the LUST grant was allocated from the Office of Underground Storage Tanks (OUST). The next LUST grant application will be submitted to U.S. EPA in the spring of 2022. A new two year UST grant (for FY22 & FY23) has been approved. The FY22 portion of the UST grant was allocated from the Office of Underground Storage Tanks (OUST).

TRAINING AND STAFF DEVELOPMENT -

BUSTR staff recently started a new cycle of ethics training and other miscellaneous training for 2022. BUSTR staff have also started a new cycle of OSHA refresher training for 2022.

TRAINING TO STAKEHOLDERS -

BUSTR provides annual Certified UST Installer and Certified UST Inspector courses. The next courses are being offered in February and March of 2022. BUSTR will be providing a continuing education course for UST Inspectors in the spring of 2022.

ACTIVITY -

The BUSTR database called Ohio Tank Tracking & Environmental Regulations (OTTER) is showing its age. OTTER went live in the year 2000 and has been updated several times. OTTER is used to house all underground storage tank records for BUSTR including registration, compliance inspections and environmental files. BUSTR is working with Commerce IT keep the OTTER platform functioning, though significant updates will be needed in the future.
