

# Petroleum Board Welcomes One New Member And Two Re-appointed Members

Governor Bob Taft has appointed one new member and re-appointed two current members to the Petroleum UST Release Compensation Board.

**Thomas G. (Tom) Stephenson** has been appointed to the Board to represent petroleum marketers for a term ending July 2003. Mr. Stephenson will be replacing his father, Richard J. Stephenson, who resigned effective July 31, 2000. The newly appointed Mr. Stephenson is currently president and owner of Stephenson Oil Co., a marketer of Chevron and Marathon products located in Hamilton, Ohio.
